ORDER

1. Government decided to accept the recommendation of the First Pay Revision Commission and hereby order as follows:
 - i. The maximum limit of Retirement Gratuity fixed in G.O.Ms.No.99, Finance (Pen-I) Department, dated.21.07.2015 be raised from Rs.12,00,000/- (Rupees Twelve Lakhs) to Rs.16,00,000/-.(Rupees Sixteen Lakhs)
 - ii. The formula for calculation of Retirement Gratuity shall be followed as ordered in para 3 of G.O.Ms.No.14, Finance & Planning (FW:Pen.I) Department, dated 30.01.1999.
2. These orders shall come into force with effect from 01.04.2020 and shall apply to all Government Servants who retired or whose death took place on or after this date.
3. The revised Gratuity shall be paid from the month of June, 2021 onwards.
4. The arrears on account of revision of Gratuity from 01.04.2020 to 31.05.2021, will be paid in Thirty Six (36) equal monthly installments.
5. The expenditure shall be met from the General Fund of the GHMC, Hyderabad.
6. All the Drawing and Disbursing Officers of GHMC are hereby instructed to implement the orders.
