Applications are invited (in the prescribed form-I, available in the Circle Offices concerned), from the women candidates belonging to representative of the Civil Societies or any other prominent citizens of the Ward concerned for nomination as members of Ward Committees in the following Wards of GHMC, as specified under the provisions of Section 8-A of the GHMC Act, 1955 read with the GHMC (Constitution, Conduct of Meetings, Powers & Functions of Ward Committees and Area Sabhas) Rules, 2010 issued by the Govt. vide G.O.Ms. No. 57 MA & UD (UBS) Dept., dated. 10.02.2010. to fulfill 50% quota from women, as specified under rule 5(1) of the said Rules.

In respect of the above mentioned wards, the Corporation (in its 04th special meeting held on 03.06.2010) have nominated the male persons from the eligible applicants (except in Ward No. 47- Shalibanda), because the number of eligible applicants fall short of the required seats to be filled from women category as per the reservation of 50% quota for women, as specified under rule 5(1) of the said rules. However, in respect of Ward No. 47-Shalibanda, only three eligible women applicants were available as against the required quota of 5 seats reserved for woman and the Corporation nominated all the three women applicants, in the said special meeting. As such, still two seats which are reserved for women, are vacant. Therefore in respect of Ward Committee No. 47-Shalibanda, all the fresh applications will be placed before the Corporation for nomination of two women candidates, as members of the respective Ward Committee.

Each Ward Committee shall consist of the following members.

- 1) The Member of the Corporation representing the Ward (Corporator of the ward concerned) will be the Chairperson of the Ward Committee.
- 2) Not more than ten representatives of the civil societies of the Ward (or) any other prominent citizen from the ward concerned.
- 3) Area Sabha representatives if there are Areas in the ward. (Separate notification will be given for this purpose).

The nominated members shall be four if the population of the Ward is not more than ten thousand. If the population of the ward is more than ten thousand, there shall be one additional member for every four thousand population or part thereof, subject to the condition that any part with population of less than two thousand shall be ignored. Fifty percent of the members to be nominated to the Ward Committee shall be woman.

Persons eligible:

- a) A president/Secretary representing registered Residents Welfare Association in the Ward.
- b) A member of registered Tax Payers Association / Rate Payers Association of the Ward:
- c) A president/secretary of slum level federation (i.e., NHC) of a slum. In case of non-availability of a slum level federation in a ward, a representative of senior most self help group in the Ward:
- d) A member of a registered association / Institution / Institute/ body or organization or Non-Governmental Organization (NGO) or Mahila Mandali or Trade Union / Chamber of Commerce / Medical Council in the Ward.
- e) Any other prominent citizen from the Ward.

Other eligibilities:

- (i) The person should not be less than 21 years of age, as on 01.01.2010.
- (ii) The person should be an elector, duly enrolled their names in the electoral rolls of the Ward concerned.
- (iii) The persons representing such civil societies of the individual ward, shall be registered one year prior to the date of nomination (except Slum Level Federation). A copy of the registration certificate should be enclosed along with the application.

Qualifications & Disqualifications: The provisions relating to qualifications & disqualification of an elected member shall apply mutatis mutandis to the members of the Ward Committees.

Term of Ward Committee: The term of office of the members of the Ward Committee shall be co-terminus with the term of office of the Corporation

Interested woman candidates may apply along with Electoral extract (in original) issued on or after 01.01.2010, by the Electoral Registration Officer concerned, in the prescribed format, to the Deputy Commissioners concerned of GHMC at their respective Circle Offices from: 07.07.2010 to 26.07.2010 (Excluding Public Holidays) between 10:30 a.m. to 3:00 p.m. daily (both days inclusive of holidays). The applications should reach the Office of the Deputy Commissioner concerned of GHMC, till 3:00 pm. on or before 26.07.2010. Those applications which are received before 3:00 p.m. on 26.07.2010 will only be considered for scrutiny. The Applications received after the prescribed date & time will be summarily rejected without assigning any reasons thereof.

The applications received will be scrutinized from: 27.07.2010 to 02.08.2010 (Excluding public Holidays) between 11:00 a.m. to 3:00 p.m. daily, by the Deputy Commissioner, GHMC (concerned) at their respective circle offices. The list of eligible applications for nominations will be placed before the Corporation in a special meeting to be convened by the H.W. Mayor for this purpose. In case there are more number of eligible applicants than the number of persons to be nominated, the Corporation will nominate the required number of persons by a voice vote.
