#### 1. <u>INTRODUCTION</u>

Empanelment of agencies for specialized painting works like Artistic painting on walls and Anti carbonation paints for Flyovers in tenders is a common practice aimed at ensuring a pool of pre-qualified and competent contractors for undertaking painting-related projects. This approach offers several benefits:

Quality Assurance: Empanelment allows the tendering authority to assess and pre-qualify agencies based on their technical expertise, experience, and financial stability, ensuring that only capable contractors are considered for the work.

Efficiency: By pre-qualifying agencies, the tendering process can be expedited as the empaneled agencies have already undergone the necessary evaluations, making the selection process more efficient.

Cost-Effectiveness: Empanelment can lead to cost savings as the agency selection process is streamlined, reducing administrative costs and time associated with evaluating each bidder for every tender.

Standardization: Empanelment helps in standardizing the quality of work by ensuring that only competent agencies, meeting pre-defined criteria, are eligible to participate in tenders.

#### 1. OBJECTIVE

The broad objective of this Bid is to Empanelment of agencies and finalizing the unit rates for ensuring a competent contractor for undertaking artistic and anti-carbonating painting related projects in Kukatpally Zone, GHMC as the unit rates of above items are not included in the SSR.

#### 2. SCOPE OF WORK

GHMC has been involved in taking up various developmental works of Public Parks and Flyover Painting. To standardizing the quality of work and unit rates of Artistic paint and Anti Carbonation Paints, tenders being invited for ensuring that only competent agencies, meeting pre-defined criteria, are eligible to participate in tenders.

#### 3. ELIGIBILITY

- The bidder may be any registered suppliers, firms or contractors who are having requisite experience and registered with concerned authority under relevant act.
- The bidder should have Similar nature of work experience in artistic painting,3D painting and anti-carbonation painting in any Govt or Pvt Organizations(OR) The bidder should have the bachelor of Degree in JNTU Fine Arts

- The bidder should have **minimum turnover of 5.00Lakhs in painting related works** in any one year during the last (03) consecutive financial years of, 2021-22, 2022-23& 2023-24.
- The bidder shall submit the Acknowledgement Copy of Latest IT Returns i.e., AY 2022-23.
- The bidder should have PAN, GST Registration Certificate (Copies shall be uploaded along with Tender)
  - The bidder shall submit the self-declaration on blacklisting/litigation/vigilance history if any

#### 4. Submission of Bid:

- a. Bid shall be submitted along with the all the Annexures filled in formats provided as appendices to this document in two cover system i.e (i) Technical Bid cover (ii) Financial Bid cover.
- b. All envelopes shall be super scribed as NAMEOF THE BIDDER......and followed by "Empanelment of agencies and Finalizing the unit rates for ensuring a competent contractor for undertaking artistic,3D painting and anti-carbonating painting related projects in Kukatpally Zone, GHMC"
- c. The Bid shall be submitted on or before Dt:14.03.2024 Time.4.00PM Hrs
- d. Submission by email or other electronic means will not be accepted. It is the responsibility of the interested party to ensure that it is delivered at prescribed address by the stated dead line through post/courier/ in person only. The Authority shall not be held responsible for any delay in delivery or lost in transit cases.
- e. All the Annexures shall be submitted duly filled with relevant information and self attested.
- f. #### **5.** Technical Bid:

- a. The applicant shall submit the following documents in a sealed cover" Technical bid cover" Covering Letter as per Annexure -I
- b. Details of the Applicant as per Annexure -II
- c. Bid security of Rs.10,000/- (Rupees Twenty Five thousand only) in shape of a Demand Draft drawn in favour of The Commissioner, GHMC" payable at Hyderabad. After completion of evaluation ,the Bid security is returned to those applicants who are not qualified at Technical Bid stage immediately after completion of the empanelment process and the Bid security of the empaneled applicants will be returned after completion of their agreement period.

#### **6.** Technical Evaluation:

- a. The committee (ZC,SE,FA,CTO &EE-23) will evaluate the technical bids first and qualify the responsive bids and the financial bids of those bidders who are technically qualified as per eligibility criteria are satisfactory shall only be opened and further evaluated for selection of the successful bidder. The lowest rate among the bids is considered as Unit rate for undertaking artistic and anti-carbonating painting related projects in Kukatpally Zone, GHMC"All the technically qualified bidders are invited to give their willingness to match with the lowest unit rate. The bidder who submit their willingness to do work at lowest unit rate in Kukatpally Zone, GHMC shall only be considered as "Empaneled Agency".
- b. The decision of the committee (ZC,SE,DC,CTO &EE-23) in the evaluation of bids shall be final. No correspondence will be entertained outside the process of evaluation. The committee (ZC,SE,DC,CTO &EE )may seek clarifications or confirmations on their bids from the bidders.
- c. During the evaluation when deemed necessary, GHMC may seek clarifications on any aspect of their bid from the agency. However, that would not entitle the agency to change or cause any change in the substance of the tender submitted or price quoted. This would also not mean that their bid has been accepted.
- d. Any effort by agency to influence the bid evaluation, bid comparison or contract award decisions may result in the rejection of the agency's bid and forfeiture of the agency's Bid Security Amount. Further, any decision taken by the (ZC,SE,DC,CTO &EE-23) GHMC in this regard is final and binding.
- e. The committee (ZC,SE,DC,CTO &EE-23) GHMC reserves the right to accept any bid, and to cancel/abort the tender process and reject all bids at any time prior to award of Contract,

without thereby incurring any liability to the affected agencies or agencies and of any obligation to inform the affected agencies of the grounds for GHMC's action and without assigning any reasons.

#### **7.** Bid Security Amount:

- a. The Bidder shall furnish, as part of the Bid, Bid Security for an amount mentioned in bid data sheet in the form of Demand Draft in favour of Commissioner, GHMC only.
- b. The Bid Security amount shall be refunded for unsuccessful bidders.
- c. The Bid Security amount of the successful Bidder submitted at the time of bid submission shall be released after completion of contract period duly deducting the penalties/recoveries, etc.
- d. The Empanelled bidders who give willingness to match with lowest unit rate shall submit the Bid security amount of Rs. 10,000.00 in the form of Demand Draft drawn in the favour of the Commissioner, GHMC from any Scheduled Banks and shall be released after completion of contract period duly deducting the penalties/recoveries, etc if any.
  - The Bid Security Amount may be forfeited:
- e. If the Bidder withdraws the Bid after bid opening (opening of technical qualification part of the bid during the period of Bid validity)
- f. In the case of a empanelled Bidder, if the Bidder fails within the specified time limit to sign the Agreement.
- g. In the case of empanelled Bidder, if the Bidder fails to supply the material within stipulated time period.

#### **8.** PERFORMANCE SECURITY (During the allotment of work):

- a. The Empanelled bidders shall submit the performance security of Rs.10,000.00at the time of concluding agreement at respective zone (allotted to them).
- **b.** The same may be paid by way of demand draft from any Nationalized Bank in favour of the Commissioner, GHMC, at the time of Agreement.
