**HYDERABAD METROPOLITAN WATER SUPPLY & SEWERAGE BOARD:**

- i. All pending water supply connection applications will be cleared.
- ii. About 1000 Rain Water Harvesting structures will be constructed in various localities for improvement of ground water table.
- iii. Commissioning of the reservoirs for improvement of water supply to existing connections and also to provide new water supply connections at the following locations :
  1. Shastripuram 2. Golden Heights, 3. Budwel, 4. Suleman Nagar under Rajendranagar Circle, 5. Barkas under Chandrayangutta Division, 6. KPHB under Kukatpally Circle.
- iv. The Trunk sewer mains will be completed to prevent the sewage pollution to Hussainsagar Lake.
- v. The Trunk sewer main will be completed to prevent sewage pollution to Durgam Cheruvu.
- vi. Pipeline works taken up in Serilingampally will be completed to improve water supply at Hafeezpet, Miyapur, Chandanagar for about 20000 connections in Serilingampally Circle (enhancement of off-take sizes from trunk mains).
- vii. New water supply connections will be provided for 3000 families at Bandlaguda in Chandrayangutta Division
- viii. The distribution network will be completed in parts of zones in Malkajgiri for improvement of water supply.
- ix. The 1000 mm dia water supply main will be completed for improvement of water supply to IT areas & other residential colonies in Madhapur
- x. The 400 mm dia water supply main laid by RWS Department will be commissioned to augment the water supply to Manikonda, Puppalguda, Narsing and also new connections will be released
- xi. The 300 mm dia pipeline laid by RWS will be completed with suitable junction works and by releasing water supply from Sainikpuri Reservoir, the water supply will be provided to Jawaharnagar,

Chennapur, Dammaiguda, Rampally, Kundanpally, R.L.Nagar, Cheryala, Timmaypally etc.
