It is to inform to all the DDOs of GHMC that a separate cell has been formed in the Head Office, under Financial Advisor, GHMC (HO). In order to implement and update the instructions issued by Govt., from time to time, some details are required. All the DDOs are requested to submit the amounts deducted monthly along with the vouchers in the following format every month, without fail.

The DDOs have to invariably certify at the end of the statement that the contributions have been calculated @ 10% of pay plus DA, every month by taking necessary action.

In the circular No.14430/Pen.Contr/GHMC/2012, Dt.27.08.2012, all the DDOs were requested to submit the CPS cheques of contributory pension of AEEs working under control, to GPF Section, so as to remit the same in the newly opened Account in SBH, MCTB. Contrary to these instructions some of the DDOs are submitting a single cheque, which includes Pension Contributory Amount for the GHMC Employees and of the AEEs, due to which the concerned section is not in a position to remit the amount in two separate accounts. All the DDOs are once again requested to submit the separate cheques for AEEs and the GHMC Employees.

They are also requested to follow the above instructions scrupulously by taking necessary action and furnish the details accordingly without fail. Any deviation from these instructions will be taken to the notice of the Commissioner, GHMC.
