The government in the GO 1st cited has introduced new pension scheme to the government employees appointed on or after 01-09-2004. Accordingly deductions at the applicable rates have been made from the monthly salary of the employees towards their contributions and reference 2nd cited guidelines were issued, inter- alia for recovering arrears of CPS subscriptions @ one arrear subscriptions along with current month subscription.

In view of the stabilization of the scheme the orders issued vide reference 3rd cited for clearing the DA& PRC-2010 arrears i.e.10 % of amount should be credited to the pension contribution account remaining 90% to be paid in cash .

As per opinion of Chief Examiner of Accounts for passing the claim the following information is to be submitted along with the claim in the prescribed proforma.


