Whereas it appears to the Government of Telangana/Special Collector (LA) & Commissioner, GHMC, that a total of **10029.8 Sq. This Notification is made under the provisions of Section-11(1) of the Right to Fair Compensation and Transparency in Land acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act no.30/2013), as amended by the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (Telangana Amendment) Act, 2016 (Act No. 21 of 2017) to all whom it may concern.

A plan of the land may be inspected in the office of the Special Collector (LA) & Commissioner, GHMC, Hyderabad on any working day during the working hours. The Government of Telangana / Special Collector-cum-Appropriate Government is pleased to authorize Officer i.e., Special Deputy Collector, Land Acquisition, GHMC, Hyderabad and his staff to enter upon and survey land, take levels of any land, dig or bore into the sub-soil & do all other acts required for the proper execution of their work as provided and specified in Section -12 of the said Act.

Under Section 11 (4) of the Act, no person shall make any transaction or cause any transaction of land i.e. sale / purchase, etc., or create any encumbrances on such land from the date of publication of such Notification without prior approval of the Special Collector.

Objections to the acquisition if any, and claims from all the persons interested/affected for settlement by negotiation of the compensation, may be filed by the person interested in the land within 60 (sixty days) from the date of publication of this Notification as provided under Section 15 of the Act before Special Collector/Authorized officer.
