**ORDER:**

To enhance Ease of Doing Business in the G.O. 1<sup>st</sup> read above orders were issued authorizing the Sub Registrars of Registration & Stamps Department to collect the Mutation Fee at the time of transfer of immovable property by way of sale or gif and rates of mutation fee to be collected were given in the Annexure of the said G.O. After issue of above G.O. it has come to notice of the Government that in Greater Hyderabad Municipal Corporation area the prevailing rate of mutation fee is 0.1% of the register document value and not 0.5% as indicated in the above G.O.

2. Therefore, Government hereby issue the following errata to G.O.Ms.No.155, MA dt.30.05.2016 and same is deemed to have been come into force with effect from 30.05.2016.

**ERRATA**

In Annexure of G.O.Ms.No.155 MA&UD, dt: 30.05.2016 against Sl.No.68 under Column 3 (i.e., the mutation fee per assessment in Greater Hyderabad Municipal Corporation) the words '**0.5% on registered document value**' are substituted with the words '**0.1% on registered document value**'.
