Government Employees from **1<sup>st</sup> of January, 2017** –

1. The Government of Telangana in the GOMsNo.135 Finance (HRM-IV) Department dt:22-09-2017 has sanctioned the Dearness Allowance from **1<sup>st</sup> January 2017** from **22.008% to 24.104% i.e.2.096%** of Basic Pay to the State Government Employees.
2. As per Para 7 of G.O., the Dearness Allowance shall be paid in cash with the salary of **September-2017 payable on 25<sup>th</sup> September, 2017**. The arrears on account of payment of Dearness Allowance for the period from **01<sup>st</sup> January, 2017 to 31<sup>st</sup> August, 2017** shall be credited to the General Provident Fund Account of the respective employees.
3. In the case of employees who are due to **retire on or before 30th November 2017**, the arrears of Dearness Allowance shall be drawn and paid in cash as the employee due to retire on superannuation is exempted from making any subscription to the General Provident Fund during the last four months of service.
4. However, in the case of an employee who ceases to be in service prior to the opening of a General Provident Fund account, the arrears so impounded shall be drawn and paid with interest on the date on which such employee ceases to be in service.
5. In respect of those employees who were appointed to Government Service on or after 01-09-2004 and are governed by the Contributory Pension Scheme (CPS), the 10% of the DA arrears from **01<sup>st</sup> January, 2017 to 31<sup>st</sup> August, 2017**, shall be credited to the CPS / PRAN accounts of the individuals along with Government share as per the existing orders and the remaining 90% of the DA arrears shall be paid in Cash

6. In the event of death of any employee before the issue of these orders, the legal heir (s) shall be entitled to the arrears of Dearness allowance in cash.

7. The term 'Pay' for this purpose shall be as defined in F.R.9 (21) (a)(i).

8. All the Drawing and Disbursing Officers and Audit Officers are requested to intimate to the employees working under their control as to how much amount of arrears of Dearness Allowance is credited to the General Provident Fund Account / Contributory Pension Scheme. They are further requested to adhere to the above instructions and any deviation or non-compliance of these instructions will be viewed seriously.
