**ORDER:**

1. The Government in the GOMs.No.136, Dt.22-09-2017 Finance (HRM-V) Department have revised the Rates of Dearness Relief from 1<sup>st</sup> January 2017 **from 22.008% of the Basic Pay to 24.104%** in respect of,

- i) Those who retired from service after 01-07-2013 and drawing pension in the Revised Pay Scales, 2015:
- ii) Those who retired prior to 01-07-2013 and whose pension was consolidated in the light of orders issued in the G.O.3<sup>rd</sup> above

2. Government also ordered the revision of rates of Dearness Relief from 99.296% to 102.72% with effect from 01-01-2017 to the Pensioners who are drawing their pension in revised pay scales, 2010 and not consolidated in terms of the orders issued in the reference 3<sup>rd</sup> read above.

3. These orders are applicable to Pensioners in receipt of Service Pensions, Family Pensions under Revised Pension Rules, 1951, Andhra Pradesh Liberalised Pension Rules, 1961 and Andhra Pradesh Government Servants (Family Pension) Rules, 1964.

4. These orders are not applicable to financial assistance grantees and others who are not entitled to Dearness Relief.
5. The amount of Dearness Relief shall be rounded off to the next rupee.
6. The arrears of revised Dearness Relief to the pensioners shall be paid along with the pension of November 2017 payable on 1<sup>st</sup> December 2017.
